## Registration and Payment Steps

1. Please fill out this form, download it to your computer with changes, and email it to [info@icreate.ca](mailto:info@icreate.ca).
2. Submit the party fee including a non-refundable minimum fee of \$210 at least 7 days before the day of the party. Payment method: e-transfer.
3. Distribute COVID-19 Preventive Protocol shown on page 2 to all party invitees to inform them about our pandemic preventive measures.

## Changes and refunds

A party cancellation or a reduction of the number of participants must be communicated to iCreate staff no later than 24 hours before the start of the party in order to receive a refund minus the non-refundable minimum fee of \$210. Refunds are not applicable for non-shows, or persons unable to attend due to sickness or the lack of the proof of a required vaccination status.

### Safety waiver

Registrants' safety is the iCreate's staff highest priority. ## COVID-19 Preventive Protocol

(To be distributed by the party organizer to all party invitees)

- All persons entering the building including our party participants and their parents/guardians must wear facial coverings.
- Only party participants, birthday child's parents, and iCreate staff members can enter the studio. Parents/guardians dropping off or picking up their kids are asked to stay outside of the studio.
- The registrant is not allowed to attend the party if he/she exhibits any COVID-19 symptoms. Please follow Public Health isolation measures if you or any of your household members or close contacts exhibit COVID-19 symptoms.
- **We also require from our program participants or their parents to conduct a screening for COVID-19 symptoms prior to coming to the party. If the participant or any of his/her household members are exhibiting any of the symptoms listed below you must not attend the party.**

List of symptoms to screen for before coming to the party:

- o Fever or chills
- o Cough
- o Shortness of breath
- o Decreased or loss of taste or smell
- o Runny nose or nasal congestion
- o Headache
- o Extreme fatigue
- o Sore throat
- o Muscle aches or joint pain
- o Gastrointestinal symptoms (such as vomiting or diarrhea)
